## 7. HANDLING AND STORAGE

#### Precautions for safe handling

If contact is made, wash skin with soap and water. Launder soiled clothing. Maximum handling temperature is 70 degrees C (158 F). It is recommended to pump or transfer material at ambient temperature.

#### Conditions for safe storage, including any incompatibilities

**Storage Conditions** Keep away from heat and sources of ignition. Keep containers closed when not in use. Follow first aid measures if contact occurs, and spill procedures if spill occurs. For packaged material: Store in a cool dry area. For bulk material: store in cool dry area. Always follow local, state, and federal guidelines for storage of material for amount stored.
